OFFICIAL FOREIGN RESERVES
August 2012

Official foreign reserves held by the National Reserve Bank of Tonga (NRBT) rose by \$1.6 million over August 2012, to \$252.7 million, or 9.5 months of goods imports. The increase in foreign reserves was due mainly to the receipt of remittances and foreign aid. Compared with August 2011, official foreign reserves rose by \$40.3 million.
